**RESOLUTION: AUTHORIZING TEMPORARY WAIVER OF PERMIT FEES CHARGED PURSUANT TO TOWNSHIP ORDINANCES FOR REPAIR WORK AND/OR IMPROVEMENTS DUE TO RECOVERY FROM FLOODING EVENT**

**WHEREAS**, the Township of Bloomfield experienced unprecedented flooding due to Tropical Storm Ida which began impacting New Jersey on Wednesday, September 1, 2021 and resulted in substantial property damage to homes and businesses throughout the Township; and

**WHEREAS**, the Township of Bloomfield is desirous of relieving construction and zoning permit application fee burdens for repair and replacement work being done solely due to recovery from said weather event; and

**WHEREAS**, the Mayor and Township Council find it in the public's best interest to authorize the waiver of fees associated with the work to repair said losses, in order to encourage the quick and efficient recovery and repair of damages.


**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex and State of New Jersey, that construction and zoning permit application fees charged pursuant to the Township Code, Chapters 149, 206, 315 and 406 shall be waived until December 1, 2021 for repair work and/or improvements accomplished solely due to recovery from the impact of Tropical Storm Ida.

**BE IT FURTHER RESOLVED** that repair work and/or improvements, or subcomponents thereof, accomplished which are not due to said weather event shall not be eligible for this fee waiver. Upon review of construction or zoning permit application materials, the Construction Official or Zoning Officer shall have the authority to make the determination of
