2021 RESOLUTION CHAPTER 159

RESOLUTION REQUESTING APPROVAL OF ITEMS OF REVENUE AND APPROPRIATION NJS 40A:4:87

BUDGET CHAPTER 159/3

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of any items of appropriation for equal amount; and

WHEREAS, after the 2021 budget was adopted, the Township of Bloomfield became informed of the availability of revenue in the amount of \$50,000.00 from the New Jersey COVID-19 Vaccination Supplemental Funding Grant SFY 2022 # G-02-40-394-014.

NOW, THEREFORE, BE IT RESOLVED, the Township of Bloomfield hereby requests the Director of the Division of Local Government Services approve the insertion of an item Assistance to New Jersey COVID-19 Vaccination Supplemental Funding Grant SFY 2022 # G-02-40-394-014; and




