2021 RESOLUTION APPROVAL

RESOLUTION: RESCINDING RESOLUTION NUMBER 9673 DIRECTING THE TOWNSHIP OF BLOOMFIELD PLANNING BOARD TO INVESTIGATE AND PREPARE AN AMENDMENT OR REVISION TO THE BLOOMFIELD CENTER REDEVELOPMENT- PHASE II

WHEREAS, on October 18, 2021 the Mayor and Council of the Township of Bloomfield approved Resolution # 9763, directing the Bloomfield Planning Board to investigate and prepare an amendment or revisions to the Bloomfield Center Redevelopment Plan - Phase II to permit a single-use multi-unit residential property on the former Sacred Heart School site located in Tax Block 244 between Bloomfield Avenue and State Street; and


WHEREAS, the Mayor and Council have subsequently authorized the Planning Board to undertake an investigation for the non-condemnation redevelopment of the same property, specifically identified as Block 244, Lots 10, 15, 41, 42 and 46, thereby making the action taken in Resolution #9763 no longer necessary.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield hereby rescinds Resolution number 9763, titled RESOLUTION OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY, DIRECTING THE TOWNSHIP OF BLOOMFIELD PLANNING BOARD TO INVESTIGATE AND PREPARE AN AMENDMENT OR REVISION TO THE BLOOMFIELD CENTER REDEVELOPMENT PLAN - PHASE II, PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW N.J.S.A. 40A:12A-1, ET SEQ. TO PERMIT A SINGLE-USE MULTI-UNIT RESIDENTIAL PROPERTY ON THE FORMER SACRED HEART SCHOOL SITE,

LOCATED IN TAX BLOCK 244 BETWEEN BLOOMFIELD AVENUE AND STATE STREET.




