2021 RESOLUTION AWARD OF CONTRACT

2021 RESOLUTION - AWARD OF CONTRACT - 2021 HYDRANT REPLACEMENT PROGRAM - CONTRACT 2

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on November 9, 2021 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the 2021 Hydrant Replacement Program - Contract 2; and

WHEREAS, a total of five bids were received and referred to the Township Engineer for review; and

WHEREAS, after review of the bids by the Township Engineer, John Garcia Construction Company, Inc., 183 Friar Lane, Clifton, New Jersey 07103, was determined to be the lowest, responsible bidder for a total contract cost in the amount of \$257,000.00; and

WHEREAS, the Township Engineer hereby recommends that the contract be awarded to John Garcia Construction Company, Inc., 183 Friars Lane, Clifton, New Jersey 07103 in the amount of \$257,000.00; and

WHEREAS, the Director of Finance has indicated that funding is available within Capital Account W-06-55-594-001.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above work with John Garcia Construction Company, Inc., 183 Friars Lane, Clifton, New Jersey 07103 in the amount of \$257,000.00.

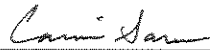

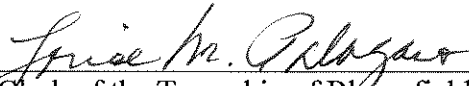

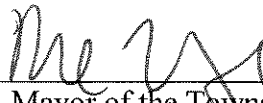
