**RESOLUTION: AUTHORIZING THE 2021 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR LION GATE PARK FRESHWATER WETLAND RESTORATION CREAMER ENVIRONMENTAL, INC.**

**WHEREAS**, the Township of Bloomfield needs the services of Creamer Environmental, Inc. to remove soil and debris, cart and properly dispose of soil as well as replace with clean fill in the Freshwater Wetland within Lion Gate Park, 1 Lion Gate Drive, Bloomfield, NJ 07003 as a direct result of damages sustained from Tropical Storm Ida on September 1, 2021; and

**WHEREAS**, the Township of Bloomfield wants to make this award under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

**WHEREAS**, the Director of Recreation & Cultural Affairs has determined that the value of these services will exceed \$17,500; and

**WHEREAS**, Creamer Environmental, Inc. 12 Old Bridge Road, Cedar Grove, NJ 07009 has completed and submitted the attached Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit Creamer Environmental, Inc. from making any reportable contributions through the duration of this contract; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in account 1-01-26-779-029 and not to exceed in the amount of \$102,610.00

**BE IT FURTHER RESOLVED**, that the Business Disclosure Entity Certification, the Township Administrator’s Determination of Value, the proposal of Creamer Environmental, Inc. and the contract itself be placed on file with this resolution; and


**BE IT FURTHER RESOLVED**, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

**BE IT FURTHER RESOLVED**, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

**BE IT FURTHER RESOLVED**, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.
