2022 RESOLUTION APPROVAL

RESOLUTION AUTHORIZING THE HOUSING AUTHORITY OF THE TOWNSHIP OF BLOOMFIELD TO OPEN THE SECTION 8 WAITING TO ACCEPT 75 APPLICANTS IN ACCORDANCE WITH SPECIFIED PREFERENCES AND PROCEDURES.

WHEREAS, the Housing Authority of the Township of Bloomfield (the “Authority”) is recommending procedures for opening the Section 8 waiting to accept 75 applicants; and

WHEREAS, the opening of the list will be advertised on the Bloomfield Township Website, social media, local newspaper, and township departments, and community partners; The ad will specify that the list will be open only for a period of 7 days, starting March 1, 2022, eliminating the need for a separate ad to close the list; and

WHEREAS, Applicants must be at least eighteen (18) years of age or an emancipated minor; and

WHEREAS, Applications will be available and completed on the Bloomfield Township’s website. Persons needing a reasonable accommodation will be instructed to contact the Authority for assistance in completing the application; and

WHEREAS, Applicants will be admitted in accordance with the following Preference Point System:

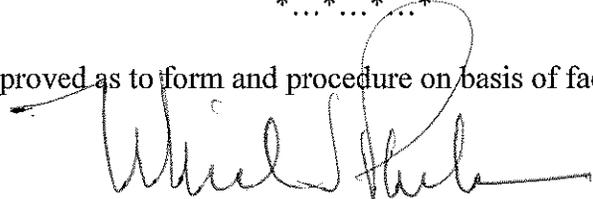
Resident is defined as someone who either lives or works in the jurisdiction; The working preference will include elderly and disabled applicants; Applicants having same number of points will be prioritized by date/time of the application.

WHEREAS, the Mayor and Council of the Township of Bloomfield act as the Commissioners and approving body for the Authority.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield that the Housing Authority of the Township of Bloomfield is authorized to open the Section 8 waiting list to accept 75 applicants in accordance with the criteria and procedures outlined herein.

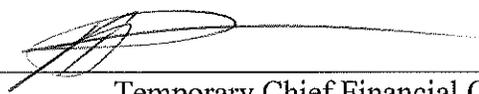
