**2022 RESOLUTION - REJECTION OF BIDS FOR THE LEAD SERVICE REPLACEMENTS - PHASES 2 & 3**

**WHEREAS** after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on July 15, 2021 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" The Lead Service Replacements - Phases 2 & 3; and

**WHEREAS**, full funding for this contract was to be provided by the New Jersey Infrastructure bank (I-Bank); and

**WHEREAS**, subsequent to the bid opening and thereafter, the I-Bank was unable to secure the funding in time for the township to award the project; and

**WHEREAS**, the Township Engineer has been advised that the funding has now been finalized and is available to the township for this funding; and

**WHEREAS**, the I-Bank has informed the Township Engineer that the funding is contingent upon rejection of the original bid due to the expiration of the 60-day review period and that the bids should be rejected and the contract re-bid; and

**WHEREAS**, it is the recommendation of the Township Engineer that the bids be rejected and the contract be re-bid in accordance to the I-Bank requirement; and

**WHEREAS**, the Mayor and Council hereby accepts the recommendations of the Township Engineer.


**NOW THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby reject the bids for The Lead Service Replacements - Phases 2 & 3 and authorize the Township Engineer to re-bid the project.
