2022 RESOLUTION APPROVAL

RESOLUTION - AUTHORIZING THE 2022 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR BLOOMFIELD PARKS, RECREATION & CULTURAL AFFAIRS DEPARTMENT SUPPORT SERVICES WITH REACH

WHEREAS, the Township of Bloomfield needs the services of professional support of their Bloomfield Parks, Recreation & Cultural Affairs Department Display Board System; and

WHEREAS, the Township desires to make this award under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

WHEREAS, the Township IT Director has determined that the value of these services will not exceed \$1,500; and

WHEREAS, REACH has completed and submitted the attached Business Entity Disclosure Certification which certifies that it has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous year, and that the month-to-month contract will prohibit REACH from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service.

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Township IT Director to enter into a contract with REACH as described herein;

BE IT FURTHER RESOLVED, that the Business Disclosure Entity Certification, the Township Administrator's Determination of Value, the proposal of REACH and the contract itself be placed on file with this resolution; and

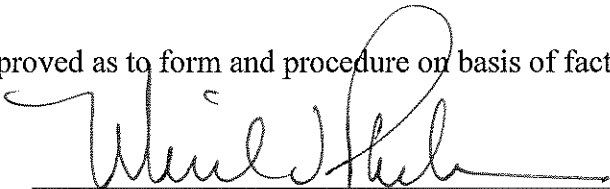
BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

BE IT FURTHER RESOLVED, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.

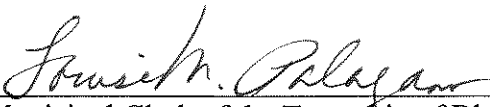
