**RESOLUTION: AUTHORIZING THE DISCHARGE OF A RESIDENTIAL REHABILITATION PROGRAM MORTGAGE LIEN FOR 14 THOMAS STREET**

**WHEREAS**, the Township's Residential Rehabilitation Program provided funding for home improvement projects to qualified homeowners within the Township of Bloomfield;

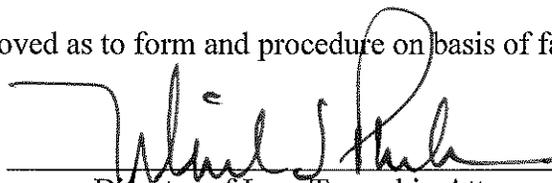

**WHEREAS**, the term of the mortgage has expired and may be discharged.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, and State of New Jersey hereby authorize and direct the Township Administrator, or his designee, to sign any documents that are necessary to discharge the mortgage lien held by the Township of Bloomfield in connection with the 2007 funding of home improvements for 14 Thomas Street.
