2022 RESOLUTION APPROVAL

**RESOLUTION: SECOND CONTRACT EXTENSION- SOLID WASTE & RECYCLING
COLLECTION SERVICES FOR THE TOWNSHIP OF BLOOMFIELD - THROUGH APRIL 30,
2022**

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on December 7, 2016 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" and N.J.A.C 7:26H-6.1 et seq., for Solid Waste Collection Services for the Township of Bloomfield; and

WHEREAS, the bids received were referred to the Township Engineer for review; and

WHEREAS, a single bid was received from, and five-year contract for Solid Waste and Recycling Collection Services was awarded to, Suburban Disposal, Inc., 54 Montesano Road, Fairfield, NJ 07004 ("**Suburban**"); and

WHEREAS, the current contract expired on December 31, 2021, and the Township is working with its consultant to prepare and advertise new bid documents for these services; and

WHEREAS, on December 13, 2021, the Township Council adopted Resolution R21-361, which authorized the Township to enter a contract extension to extend the Solid Waste Agreement for an additional period of three (3) months until March 31, 2022 ("**the first extension period**"); and

WHEREAS, since the last contract and bid documents were prepared over five years ago, there have been changes in the current labor force as well as changes in the marketplace for recyclables that have required more time to properly prepare new bid documents to properly address these new issues. This has resulted in further delays that require the Township to extend the current contract to April 30, 2022; and

WHEREAS, the Department of Law has contacted Suburban Disposal and they are agreeable to providing a second extension; and

WHEREAS, Suburban will maintain the same monthly cost of \$270,000.00 to collect the Township’s garbage and recycling, as agreed to for the first extension period; and

WHEREAS, Additionally, the Township will continue to own the recyclables, meaning that the Township will market the recyclables and will either receive a credit or a cost for disposal depending upon the current market values at the time; and

WHEREAS, funding is available within the Township’s operating budget for solid waste and recycling collection services.


NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, award a contract extension for the period April 1, 2022 through April 30, 2022 (“**the second extension period**”) for the collection of solid waste service to Suburban Disposal, Inc., 54 Montesano Road, Fairfield, NJ 07004, at a monthly cost of \$270,000.00; and

BE IT FURTHER RESOLVED, for the second extension period, the Township will own and market the collected recyclables, and will either receive a credit or a cost for disposal depending upon the current market values at the time; and

BE IT FURTHER RESOLVED, for the second extension period, the remaining terms of service set forth in the 2016 Contract for Solid Waste Collection Services for the Township of Bloomfield, including but not limited to the existing collection schedule and frequency, shall remain in effect.


