**RESOLUTION - SOLID WASTE & RECYCLING COLLECTION SERVICES FOR THE TOWNSHIP OF BLOOMFIELD**

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on March 29, 2022 by the Purchasing Agent of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law; and

WHEREAS, a single bid was received from Suburban Disposal, Inc., 54 Montesano Road, Fairfield, NJ 07004; and

WHEREAS, the bid prices provide are as follows:

**WHEREAS**, after review of the single bid, it was determined that the contract should be awarded to Suburban Disposal, Inc. based upon the following;


1. Current market values for Solid Waste and Recycling Collection Services have substantially increased due to impacts related to the pandemic; personnel salary increases; equipment cost increases, as well as fuel increases. These increases have ranged between 30 and 150 percent over previous years.
2. Comparing our previous contract to the current bid prices indicates a 33 percent increase which falls within the lower range of the anticipated increases; and

**WHEREAS**, funding is available within the township's operating budget for solid waste and recycling collection services.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, award a contract for the collection of solid waste service to Suburban Disposal, Inc., 54 Montesano Road, Fairfield, NJ 07004 for the bid items and prices presented above.
