**2022 RESOLUTION AWARD OF CONTRACT**

**RESOLUTION: AUTHORIZING THE 2022 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR LIVE MUSIC PERFORMANCE & PROFESSIONAL SOUND THE KOOTZ C/O GLENN M. TAYLOR**

**WHEREAS**, the Township of Bloomfield needs the services of THE KOOTZ - C/O Glenn M. Taylor to supply a live music performance and professional sound during the Township of Bloomfield's Independence Day Celebration on 7/4/22 with a rain date of 7/5/22; and

**WHEREAS**, the Township desires to make this award under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

**WHEREAS**, the Township Recreation Director has determined that the value of these services will not exceed \$17,500; and

**WHEREAS**, THE KOOTZ - C/O Glenn M. Taylor, has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit THE KOOTZ - C/O Glenn M. Taylor from making any reportable contributions through the duration of this contract; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in account #R-14-20-854-031 and not to exceed in the amount of \$4,300.00.

**NOW, THEREFORE, BE RESOLVED**, that the Mayor and Council of the Township of Bloomfield authorizes the Township Recreation Director to enter into a contract with THE KOOTZ - C/O Glenn M. Taylor as described herein;

**BE IT FURTHER RESOLVED**, that no minimum payment is implied or guaranteed;

and

**BE IT FURTHER RESOLVED**, that the Business Disclosure Entity Certification, the Township Administrator’s Determination of Value, the proposal of THE KOOTZ - C/O Glenn M. Taylor and the contract itself be placed on file with this resolution; and


**BE IT FURTHER RESOLVED**, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

**BE IT FURTHER RESOLVED**, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

**BE IT FURTHER RESOLVED**, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.


