2022 RESOLUTION CHANGE ORDERS

**WEST PASSAIC AVENUE WATERMAIN REPLACEMENT OVER THE GARDEN
STATE PARKWAY - CHANGE ORDERS 1 AND 2**

WHEREAS, the Township of Bloomfield entered into a contract for the Watermain Replacement over the Garden State Parkway with J. Fletcher Creamer and Son, Inc., Hackensack, NJ in the amount of \$260,800.00; and

WHEREAS, during the course of the project, it was necessary to adjust or modify the amount of construction items to account for unforeseen site conditions, including the need for a 16-inch insertion valve; and

WHEREAS, the Township Engineer and the project consultant, The Alaimo Group, have reviewed the changes enumerated in Change Orders 1 and 2 and recommend the Change Orders be approved; and

WHEREAS, Change Order Nos. 1 and 2 represent an increase in the cost of the contract in the amount of \$38,969.59 for a revised contract amount of \$299,769.59 or a total increase of 14.9% to the original contract price; and

WHEREAS, funding is available within the Township Water Utility Capital Account No. W-06-55-594-001; and


WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer, is satisfied that the specified changes should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and






