2022 RESOLUTION AWARD OF CONTRACT

RESOLUTION: AUTHORIZING THE 2022 AWARD OF A NON-FAIR AND OPEN CONTRACT TO BROOKDALE SHOP RITE FOR THE MAYOR AND COUNCIL'S 2022 THANKSGIVING TURKEY GIVEAWAY

WHEREAS, the Township of Bloomfield wishes to purchase turkeys and fixings to serve approximately 700 families for the Mayor and Council's 2022 Annual Thanksgiving Turkey Giveaway; and

WHEREAS, Brookdale Shop Rite in Bloomfield has expressed interest and can supply the necessary goods for this event; and

WHEREAS, the Township desires to make this award under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

WHEREAS, the Township has determined that the value of these services will exceed \$17,500; and

WHEREAS, Brookdale ShopRite has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit Brookdale ShopRite from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service in account 2-01-20-703-191 and not to exceed in the amount of \$20,000.

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Township to enter a contract with Brookdale ShopRite as described herein; and

BE IT FURTHER RESOLVED, that the Business Disclosure Entity Certification, the Township Administrator's Determination of Value, the proposal of Brookdale ShopRite and the contract itself be placed on file with this resolution; and

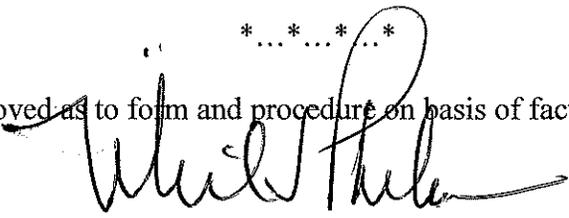
BE IT FURTHER RESOLVED that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days' notice and the Professional shall only be paid for products delivered or on a pro-rated amount if the contract calls for a monthly retainer; and

BE IT FURTHER RESOLVED that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.

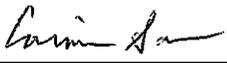
