2022 RESOLUTION - AWARD OF CONTRACT - TRAFFIC SIGNAL REPLACEMENTS AND REPAIRS

WHEREAS, The Bloomfield Engineering Department is in need of a contractor to make repairs and replacements to a number of township-owned traffic signals at various locations; and

WHEREAS, the Bloomfield Engineering Department was unable to obtain responsive bids or quotes in order to get this work completed; and

WHEREAS, Jen Electric, Inc., 631 Morris Avenue, Springfield, NJ 07081 possess the contract with the Morris County Cooperative Pricing Council (MCCPC) for traffic signal repairs and installation under Contract Number 37; and

WHEREAS, the Township Of Bloomfield is a member of the MCCPC; and

WHEREAS, the total cost of these repairs for in-kind replacement is \$61,875.00; and

WHEREAS, it is the recommendation of the Township Engineer that the township utilize the MCCPC contract to make these repairs and replacements at a cost of \$61,875.00; and

WHEREAS, the Director of Finance has indicated that funding is available through Township Capital Account No. C-04-55-734-001.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above improvements with Jen Electric, Inc., 631 Morris Avenue, Springfield, NJ 07081 at a cost of \$61,875.00.
