**RESOLUTION - AWARD OF CONTRACT - 2022-2023 SNOW PLOWING & REMOVAL CONTRACT FOR THE TOWNSHIP OF BLOOMFIELD**

**WHEREAS**, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on December 20, 2022 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for Snow Plowing and Removal Services for the Township Of Bloomfield; and

**WHEREAS**, a total of three bids were received and subsequently referred to the Township Engineer for review; and

**WHEREAS**, the unit prices provided by Stanziale Construction in their proposal for Base Bid A - Snow Plowing are as follows:

**BASE BID A - SNOW PLOWING**

A-1	Single Axle Truck (minimum 26,000 GVWR)	2 trucks at \$275/hour per truck
A-2	Tandem axle trucks (minimum 26,000 GVWR)	4 trucks at \$275/hour per truck
A-3	Single axle trucks (minimum 12,000 GVWR)	6 trucks at \$275 hour per truck A-4
	Calcium Chloride ice melt materials	\$1.90 per pound
A-5	Sodium Chloride ice melt materials	\$0.40 per pound

and;

**WHEREAS**, the unit prices provided by American Asphalt in their proposal for Base Bid B - Snow Removal are as follows:

**BASE BID B - SNOW REMOVAL & HAULING**

B-1	20 cu. yd. roll offs truck for hauling	2 trucks at \$250 hour per truck
B-2	Tandem axle trucks	50 trucks at \$200 hour per truck
B-3	Tri-axle trucks	50 trucks at \$200 hour per truck
B-4	Front-end Bucket Loaders (Minimum 2.5 C.Y.)	5 trucks at \$350 per loader

; and

**WHEREAS**, it is the recommendation of the Township Engineer that Base Bid A - Snow Plowing be awarded to Stanziale Construction, PO box 2597, Bloomfield, NJ 07003 at the unit prices provided above in an amount not to exceed \$100,000.00; and

**WHEREAS**, it is the further recommendation of the Township Engineer that Base Bid B - Snow Removal be awarded to American Asphalt, 818 Summer Avenue, Newark, New Jersey 07104 at the unit prices provided above in an amount not to exceed \$20,000.00; and

**WHEREAS**, no minimum payment for these services is implied or assumed; and

**WHEREAS**, the Director of Finance has certified that funds are available within the Department of Public Works account T-13-56-013-SR1.

**NOW THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above services with Stanziale Construction, LLC, PO Box 2597, Bloomfield, NJ 07003 for the unit prices provided in their proposal for Base Bid A in an amount not to exceed \$100,000.00.

**BE IT FURTHER RESOLVED** that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above services with American Asphalt, 818 Summer Avenue, Newark, New Jersey 07104 for the unit prices provided in their proposal for Base Bid B an amount not to exceed \$20,000.




