2023 RESOLUTION - AUTHORIZING THE 2023 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR PROFESSIONAL SUPPORT OF POLICE MOTOROLA/Wireless C&E CAR MOBILE DATA TECH SYSTEM SUPPORT

WHEREAS, the Township of Bloomfield Police Department needs the services of professional support of their Car Mobile tech Equipment systems; and

WHEREAS, the Township desires to make this appointment under the provisions N.J.S.A. 19:44A-20.5, as a non-fair and open contract; and

WHEREAS, the Township Public Safety Police Director has determined that the value of these services will exceed \$17,7500; and

WHEREAS, Motorola/Wireless Com has completed and submitted the attached Business Entity Disclosure Certification which certifies that the company has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous year, and that the contract will prohibit Motorola. from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service in an amount not to exceed \$68,500 in account# 3-01-20-707-024; and

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Township Public Safety Police Director to enter into a contract with Motorola/Wireless Comm as described herein; and

BE IT FURTHER RESOLVED, that no minimum payment is implied or guaranteed; and

BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the

Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, authorizes the Township Public Safety Director to enter into a contract with Motorola/Wireless Communications as described herein.
