2023 ORDINANCE NEW ORDINANCE

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (684) 103 Johnson Avenue, West curb, starting at a point 53 feet West of the Southern curb line of Johnson Avenue running 20 feet West therefrom. Placard P2540034
- (685) 142 Orchard Street, West curb line, starting at a point 257 feet South of the Southern curb line of Belleville Avenue running 20 feet West therefrom. Placard P2530337
- (686) 73 N. 13th Street Apt. 1, West curb line, starting at a point 250 feet South of the Southern curb line of 2nd Street and running 20 feet West therefrom. Placard P2644486
- (687) 25 Curtis Street Apt 2, East curb line, starting at a point 160 feet South of the Southern curb line of Marcy Street and running 20 feet West therefrom. Placard P2488043
- (688) 44 Prospect Street, West curb line, starting at a point 145 feet North of the Northern curb line of Willow Street and running 20 feet East therefrom. Placard P2642070
- (689) 157 N. 15th Street, West curb line, starting at a point 220 feet South of the Southern curb line of Abington Avenue and running 20 feet East therefrom. Placard P2647355
- (690) 19 Van Winkle Street Apt D, South curb line, starting at a point 375 feet East of the Eastern curb line of Davey Street and running 20 feet East therefrom. Placard P2265507
- (691) 236 N. 17th Street, Beardsley Avenue, South curb line, starting at a point 168 feet North of the Eastern curb line of North 17th Street and running East therefrom. Placard P2515964
- (692) 150 Baldwin Street, N. Spring Street, West curb line, starting at a point 271 feet West of the Southern curb line of Baldwin Street and running 20 feet East therefrom.

- (693) 47 Oakland Avenue Apt 23, Fremont Street, South at a point 90 feet South of the Eastern curb line of Oakland Avenue and running 20 feet South therefrom. Placard P2386554

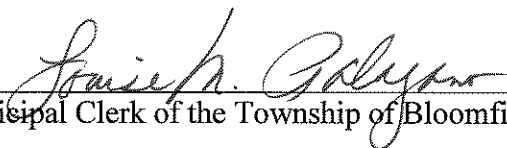
Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.

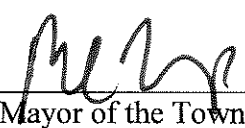
