2023 RESOLUTION CHANGE ORDERS

2023 RESOLUTION - PURCHASE & INSTALLATION OF CUSTOMER WATER METERS - CHANGE ORDER NO. 2

WHEREAS, the Township of Bloomfield entered into a contract for the Purchase & Installation of Customer Water Meters with Core & Main, LP, 61 Gross Avenue, Edison, NJ 08837 (hereinafter "the Contractor") for a total contract amount \$4,459,226.50; and

WHEREAS, during the course of the work, a number of unforeseen conditions occurred requiring changes to the contract amount. These changes included the purchase of additional meters of varying sizes; appurtenant plumbing accessories; modifications to the piping to accommodate certain meters and the need for confined space measures for those meters that could only be placed in meter pits; and

WHEREAS, Change Order No. 2 represents an increase in the contract amount of \$212,088.00. Factoring in previous Change Order No. 1, the total increase to the original contract price of \$4,459,226.50 is 8 percent; and

WHEREAS, the Change Order request was reviewed by the project consultant and determined to be necessary; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, funding is available within the Capital Bond Ordinance W-06-55-593-001, which is reimbursable through the NJ Infrastructure Bank program; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the Change Order should be approved.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey that Change Order No. 2 is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.

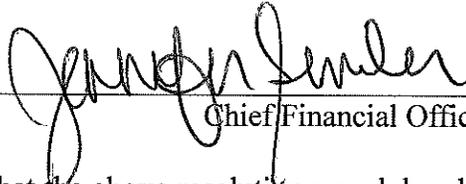

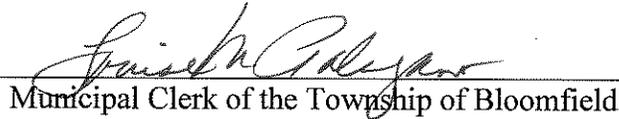
