2023 RESOLUTION AWARD OF CONTRACT

**RESOLUTION: AUTHORIZING THE AWARD OF A PROFESSIONAL SERVICES
CONTRACT FOR LANDSCAPING SERVICES AT LION GATE PARK TO
PROPERTY SERVICES LANDSCAPING**

WHEREAS, the Township of Bloomfield requires the services and has advertised the need for Landscaping Services at Lion Gate Park on the Township of Bloomfield's website and the Independent Press as part of the fair and open process pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Director of Parks, Recreation & Cultural Affairs has certified in writing that the value of the service will exceed \$17,500; and

WHEREAS, Property Services Landscaping, 344 Broughton Ave., Bloomfield, NJ 07003 (hereinafter "Professional") has submitted a proposal to provide said services; and

WHEREAS, after review and evaluation of the proposals it is recommended that a contract for the services be awarded to Property Services Landscaping in the amount not to exceed \$28,765.00; and

WHEREAS, this contract will take effect on Tuesday, March 28, 2023 and will end on December 31, 2023 or until a successor is appointed; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of these services in account # 3-01-28-795-024; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes and directs the Director of the Parks, Recreation & Cultural Affairs Department to enter into a contract/retainer agreement with the Professional within 10 days as described; and

BE IT FURTHER RESOLVED, that this contract/retainer agreement is entered into in accordance with the Standardized Submission Requirements for Professional Services and no minimum payment is implied or guaranteed; and

BE IT FURTHER RESOLVED, that all of the terms contained in the Standardized Submission Requirements for Professional Services are incorporated into the Professional's contract/retainer unless specifically excluded; and

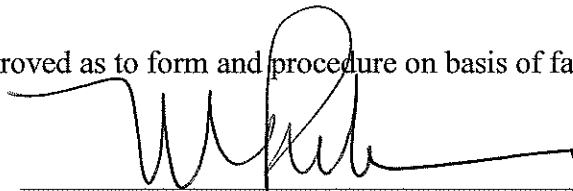
BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contract calls for a monthly retainer; and

BE IT FURTHER RESOLVED, that the Professional's response to the request for Professional Services shall be placed on file with this resolution and a copy of the contract/retainer agreement entered into; and

BE IT FURTHER RESOLVED, that the contract should incorporate the terms and conditions contained in Professional's response to the request for Professional Services.

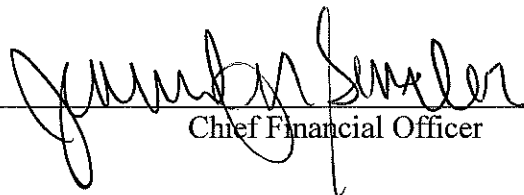
