RESOLUTION: AUTHORIZING PUBLIC AUCTION OF ABANDONED MOTOR VEHICLES (POLICE DEPARTMENT)

WHEREAS, vehicles in violation, accidents, and/or abandoned will be towed off the street by a licensed Towing Company designated by the Township of Bloomfield; and

WHEREAS, the Township of Bloomfield is authorized to sell at Public Auction abandoned/ unclaimed motor vehicles pursuant to State Law.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

(1) The sale of the vehicles shall be conducted through GovDeals pursuant with the Sourcewell National Cooperative. The terms and conditions of the agreement entered with GovDeals is available online at govdeals.com and available from the Township of Bloomfield.

(2) The sale will be conducted online from March 29, 2023 to April 5, 2023, and the address of the auction site is GovDeals.com.

(3) The sale is being conducted in accordance with N.J.S.A. 39:10A-1 and N.J.S.A. 40A:14-157.



(6) The Police Department reserves the right to accept or reject any bid submitted.






