AN ORDINANCE CODIFYING CHAPTER 5, "ADMINISTRATION OF GOVERNMENT," Part 6. Additional Committees, Boards and Commissions, ARTICLE XXVIII "Municipal Youth Guidance Council," IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD

WHEREAS, N.J.S.A. 9:22-1 enables a municipal governing body to appoint a municipal youth guidance council for the municipality of not to exceed seven members and all of whom shall be residents of said municipality; and

WHEREAS, on March 15, 1965, the Town Council of the Town of Bloomfield determined that a youth guidance council should be established, in the best interests of "Bloomfield and its inhabitants", to perform the duties and exercise the powers provided for under N.J.S.A. 9:22-1, et seq.; and

WHEREAS, the Mayor and Township Council wish to codify this action and establish a Municipal Youth Guidance Council within the Code of the Township of Bloomfield.

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 5, "ADMINISTRATION OF GOVERNMENT," Part 6. Additional Committees, Boards and Commissions, of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to establish the following:

ARTICLE XXVIII "Municipal Youth Guidance Council,"

§5-143. Municipal Youth Guidance Council.

- A. There shall be a Municipal Youth Guidance Council, as provided for under N.J.S.A. 9:22-1, et seq.
- B. The Council shall consist of seven (7) residents of the Township, each of whom shall be appointed by the Mayor and shall have full member voting rights. The membership of the Municipal Youth Guidance Council shall include:
 - 1. at least one representative of the municipal governing body;
 - 2. one representative of the school system; and
 - 3. one representative of the municipal police department.

The remaining four (4) members may be comprised of residents of the Bloomfield community.
- C. Members shall be appointed to serve for a term of three years or until their successors be appointed with the exception that the terms of the original membership of the council shall be so constituted as to provide that three of the members shall serve for one year, two for two years, and two for three years. No member shall serve on the committee longer than six (6) consecutive years.
- D. Upon the expiration of a committee member's initial term under this section, the Mayor shall either reappoint that committee member or appoint his/her replacement.
- E. Vacancies shall be filled by the Mayor only for the unexpired term.
- F. The members shall organize annually by selecting a chair, vice-chair and secretary. The Municipal Youth Guidance Council shall meet regularly, at least once each month, and at such other times as its chair shall direct.
- G. The members of this Committee shall not receive compensation for their services.

§5-144. Powers and duties.


The Powers and Duties of the Municipal Youth Guidance Council are established by and set forth in N.J.S.A. 9:22-5 through N.J.S.A. 9:22-6.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
