**2023 RESOLUTION - AWARD OF A PROFESSIONAL SERVICE CONTRACT FOR DESIGN AND BID SERVICES FOR THE 2023 NJDOT LOCAL TRANSPORTATION PROJECTS PROGRAM - CONTRACT B**

**WHEREAS**, the Township of Bloomfield has a need to acquire professional services for Design and Bid Services for the 2023 NJDOT Local Transportation Projects Program - Contract B; and

**WHEREAS**, the Township desires to make this appointment using one of our previously approved consultants for General Engineering Services; and

**WHEREAS**, the Township Engineer has determined that the value of these services may exceed \$17,500.00; and

**WHEREAS**, the Township Engineer solicited proposal from the various consultants providing General Engineering Services to the Township; and

**WHEREAS**, T & M Associates, 1455 Broad Street, Suite 250, Bloomfield, NJ 07003 (hereinafter the "professional") were determined by the Township Engineer to be most qualified in experience and cost to provide these services; and

**WHEREAS**, the professional will provide these services at a cost not to exceed \$64,220.00; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of these services through the Roadway Capital Account No. C-04-55-740-001.


