**RESOLUTION: AUTHORIZING THE 2023 AWARD OF A CONTRACT FOR  
TOWNSHIP PLANNING BOARD CONSULTING SERVICES TO PHILLIPS PREISS  
GRYGIEL LEHENY HUGHES LLC**

**WHEREAS**, the Township of Bloomfield needs the services of Phillips Preiss Grygiel Leheny Hughes LLC to provide professional Township Planning Board Consulting Services for the Township of Bloomfield; and

**WHEREAS**, the Township Administrator has determined that the value of these services will exceed \$17,500; and

**WHEREAS**, Phillips Preiss Grygiel Leheny Hughes LLC ("**Consultant**") has submitted a proposal and possesses the necessary qualifications to assist the Township with their needs; and

**WHEREAS**, Consultant will bill for any such services based on their standard 2023 municipal hourly rates as set forth in their proposal; and

**WHEREAS**, after review and evaluation of the proposals and the hourly rates it is recommended that a contract for the services be awarded Phillips Preiss Grygiel Leheny Hughes LLC, in the amount not to exceed \$50,000.00; and

**WHEREAS**, this contract will take effect on January 1, 2023 and will end on December 31, 2023 or until a successor is appointed; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of these services in account # 3-01-21-720-028; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorizes the Township Administrator to enter into an agreement with the Professional described herein.
