**CORRECTING RESOLUTION: APPOINTMENT OF GARY PETERS AS  
TEMPORARY POLICE OFFICER EFFECTIVE JULY 19, 2022**

**WHEREAS**, there are vacancies in the Bloomfield Police Department for police officers;  
and

**WHEREAS**, the candidate has met the requirements of the Bloomfield Police Department hiring process for police officers; and

**WHEREAS**, in order to comply with NJSA 11A:4-1.3 Gary Peter's appointment date for Civil Service shall be July 19, 2022, and

**WHEREAS**, the candidate will complete a full Basic Course for Police Officers training course at a school approved and authorized by the New Jersey Police Training commission within nine months from the date of hire as a temporary entry-level officer under the provisions of NJSA 11A:4-1.3; and

**WHEREAS**, Upon successful completion of the training course, Gary Peters shall be appointed from a temporary to a permanent entry-level law enforcement police officer under the provisions of NJSA 11A:4-1.3, and

**WHEREAS**, the Chief of Police recommends that Gary Peters be appointed to the position of Temporary Police Officer ; and

**WHEREAS**, the Director of Finance has indicated that funding is available for this appointment.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Gary Peters is hereby appointed as a

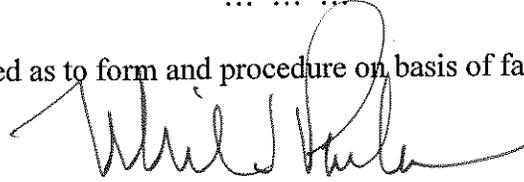

July 19, 2022 at step one in the annual salary in effect in the salary ordinance.

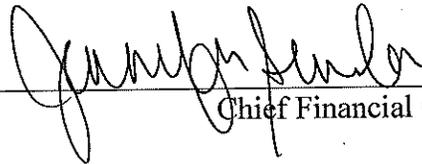

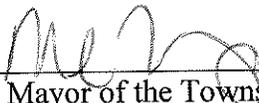
