2023 RESOLUTION AWARD OF CONTRACT

RESOLUTION: AUTHORIZING THE 2023 AWARD OF A NON-FAIR AND OPEN CONTRACT TO CONTEMPORARY GLASS SERVICES, INC. FOR REPAIRS TO TOWNSHIP OF BLOOMFIELD FIRE DEPARTMENT LOCATIONS

WHEREAS, the Township of Bloomfield needs the services of company to make certain glass repairs to several Township of Bloomfield Fire Department locations; and

WHEREAS, the Township desires to make this award under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

WHEREAS, the Fire Chief has determined that the value of these services will exceed \$17,500; and

WHEREAS, Contemporary Glass Services, Inc., 158 Bloomfield Avenue, Nutley, NJ 07110 has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit Contemporary Glass Services, Inc. from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service in account # _____ and not to exceed in the amount of \$27,200.00.

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Fire Chief to enter into a contract with Contemporary Glass Service, Inc. as described herein;

BE IT FURTHER RESOLVED, that no minimum payment is implied or guaranteed; and


BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days’ notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

BE IT FURTHER RESOLVED, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.
