**RESOLUTION: AUTHORIZING THE 2023 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR MUSICAL ENTERTAINMENT AND SOUND EQUIPMENT LA GUARDIA & ASSOCIATES**

**WHEREAS**, the Township of Bloomfield needs the services of LA GUARDIA & ASSOCIATES, to supply professional musical entertainment and sound equipment during the Township of Bloomfield's Summer Concert Series; and

**WHEREAS**, the Township desires to make this award under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

**WHEREAS**, the Township's Director of Parks, Recreation & Cultural Affairs has determined that the value of these services will not exceed \$17,500; and

**WHEREAS**, LA GUARDIA & ASSOCIATES, 388 POMPTON AVE. CEDAR GROVE, NJ, 07009 has completed and submitted the attached Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit LA GUARDIA & ASSOCIATES from making any reportable contributions through the duration of this contract; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in account #R-14-20-854-031 and not to exceed in the amount of \$9,700.00

**NOW, THEREFORE, BE RESOLVED**, that the Mayor and Council of the Township of Bloomfield authorizes the Township Director of Parks, Recreation & Cultural Affairs to enter into a contract with the LA GUARDIA & ASSOCIATES as described herein;


**BE IT FURTHER RESOLVED**, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

**BE IT FURTHER RESOLVED**, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

**BE IT FURTHER RESOLVED**, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.
