2023 RESOLUTION - AWARD OF A PROFESSIONAL SERVICE CONTRACT FOR DESIGN, BID SERVICES AND CONSTRUCTION ADMINISTRATION FOR THE REPLACEMENT OF A SANITARY SEWER MAIN UNDER THE GARDEN STATE PARKWAY

WHEREAS, the Township of Bloomfield has a need to acquire professional services for Design, Bid Services, Construction Administration and Inspection for the replacement of a 15-inch diameter sanitary sewer main under the Garden State Parkway; and

WHEREAS, the Township desires to make this appointment using one of our previously approved consultants for General Engineering Services; and

WHEREAS, the Township Engineer has determined that the value of these services may exceed \$17,500.00; and

WHEREAS, the Township Engineer solicited a proposal from one of our general engineering consultants, the Alaimo Group, 200 High Street, Mt. Holly, New Jersey (hereinafter the "Professional"); and

WHEREAS, the Professional provided a proposal in the amount of \$88,000.00 for this service; and

WHEREAS, the Township Engineer reviewed the proposal and recommends a contract for this work be awarded to the Professional in an amount not to exceed \$88,000.00; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of these services within the following township Accounts:
