2023 RESOLUTION AWARD OF CONTRACT

RESOLUTION: AUTHORIZING THE 2023 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR OAKESIDE BLOOMFIELD CULTURAL CENTER EMERGENCY CHIMNEY REPAIR DELL-TECH INC

WHEREAS, the Township of Bloomfield needs the services of DELL-TECH INC to perform an emergency repair and reconstruction of two (2) chimneys at the Oakeside Bloomfield Cultural Center, 240 Belleville Ave. Bloomfield, NJ 07003 ; and

WHEREAS, the Township of Bloomfield wants to make this award under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

WHEREAS, the Township Finance Director has determined that the value of these services will exceed \$17,500; and

WHEREAS, DELL-TECH INC, 930 NEW YORK AVE. TRENTON, NJ 08638 has completed and submitted the attached Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous one year, and that the contract will prohibit DELL-TECH, INC from making any reportable contributions through the duration of this contract; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this service in account C-04-55-172-702 C-04-55-183-303 and not to exceed in the amount of \$55,500.00.

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield authorizes the Township Parks, Recreation & Cultural Affairs Director to enter into a contract with DELL-TECH, INC as described herein;


BE IT FURTHER RESOLVED, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

BE IT FURTHER RESOLVED, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

BE IT FURTHER RESOLVED, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.


