**2023 ORDINANCE NEW ORDINANCE**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (703) 82 Waldo Avenue, South curb, starting at a point 316 feet West of the Westerly curb line of Grove Street running 20 feet West therefrom. Placard # 2701227
- (704) 22 Seely Terrace 2<sup>nd</sup> Floor, East curb, starting at a point 385 feet Northwest of the Westerly curb line of East Passaic Avenue running 20 feet North therefrom. Placard # P2437548
- (705) 10 Curtis Street, West curb, starting at a point 114 feet North of the Northerly curb line of Baldwin Street and running 20 feet North therefrom. Placard # P22367016 (Apt. 2)
- (706) 90 North 15<sup>th</sup> Street, East curb, starting at a point 242 feet South of the Southerly curb line of First Avenue and running 20 feet South therefrom. Placard # P2025124 (Apt. 1L)
- (707) 60 Floyd Avenue, South curb, starting at a point 166 feet West of the Westerly curb line of Grove Street and running 20 feet West therefrom. Placard # P2281810 (Apt. 1)
- (708) 35 Belleville Avenue, North curb, starting at a point 97 feet East of the Easterly curb line of Patton Drive and running 20 feet East therefrom. Placard # P2519395 (Apt. B)
- (709) 161 Watsessing Avenue, East curb, starting at a point 230 feet North of the Northerly curb line of Bloomfield Avenue and running 20 feet North therefrom. Placard # 2437800
- (710) 153 Franklin Street, South curb, starting at a point 191 feet West of the Westerly curb line of Berkeley Avenue and running 20 feet West therefrom. Placard # P2648774


(711) 147 Broad Street, Beginning from, the south end of the Unnamed Public road running 180 feet of loading zone. Thereafter, 20 feet of handicapped only parking space, then 18 feet of clergy only parking space then 45 feet of No Stopping or standing of the north end of the Unnamed Public Road at Broad Street

Section 2. All ordinances inconsistent herewith are hereby repealed.


Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.


