**WHEREAS**, the Township of Bloomfield Police Department needs the services of professional support of their GTBM netCloud Service/Info-Cop Solutions; and

**WHEREAS**, the Township desires to make this appointment under the provisions N.J.S.A. 19:44A-20.5, as a non-fair and open contract; and

**WHEREAS**, the Township Chief of Police has determined that the value of these services will exceed \$17,500; and

**WHEREAS**, GTBM NetCloud Info-Cop. has completed and submitted the attached Business Entity Disclosure Certification which certifies that the company has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous year, and that the contract will prohibit GTBM NetCloud Info-Cop. from making any reportable contributions through the duration of this contract; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in an amount not to exceed \$42,500 in account# 3-01-20-140-024; and

**BE IT FURTHER RESOLVED**, that no minimum payment is implied or guaranteed; and

**BE IT FURTHER RESOLVED**, that the Business Disclosure Entity Certification, the Township Administrator's Determination of Value, the proposal of GTBM NetCloud Info-Cop. and the contract itself be placed on file with this resolution; and

**BE IT FURTHER RESOLVED**, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

**BE IT FURTHER RESOLVED**, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the

Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

NOW, THEREFORE, BE RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, authorizes the Public Safety Director to enter into a contract with GTBM NetCloud Info-Cop as described herein.
