**2023 RESOLUTION AWARD OF CONTRACT**

**RESOLUTION - AUTHORIZING THE 2023 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR TOWNSHIP COUNCIL CHAMBERS AUDIO SYSTEM UPGRADE, INSTALLATION and SUPPORT SERVICES WITH Johnston Communications Solutions**

**WHEREAS**, the Township of Bloomfield needs the services of professional support for its council chambers audio system; and

**WHEREAS**, the Township desires to make this award under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

**WHEREAS**, the Township IT Director has determined that the value of these services will exceed \$17,500; and

**WHEREAS**, Johnston Communications Solutions has submitted a quote; and

**WHEREAS**, in accordance to N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" the Township can award the services of a firm that possess a New Jersey State Contract and/or participate in a Cooperative Purchasing Committee without needing to publicly bid the work; and

**WHEREAS**, Johnston Communications Solutions, (JCT Solutions), 36 Commerce Street, Springfield, NJ 07081 is an awarded vendor under the Union County Cooperative Purchasing Committee of which the Township of Bloomfield is a member; and

**WHEREAS**, JCT Solutions has provided proposals under Cooperative Purchasing Committee number 8-UCCP 24-2021; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in an amount not to exceed \$84,835.93 in account# C-04-55-230-305; and

**BE IT RESOLVED**, that no minimum payment is implied or guaranteed; and




