**2023 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS (removal)**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4, "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the deletion of the following:

Sherman Court, West curb, starting at a point 200 feet South of Southerly curb line of Bloomfield Avenue and running 20 feet South therefrom

Sherman Court, West curb, starting at a point 154 feet South of Southerly curb line of Bloomfield Avenue and running 25 feet South therefrom (1)

Sherman Court, West curb, starting at a point 120 feet South of Southerly curb line of Bloomfield Avenue and running 22 feet South therefrom (1A)

Sherman Court, West curb, starting at a point 195 feet South of Southerly curb line of Bloomfield Avenue and running 18 feet South therefrom (4)

Sherman Court, West curb, starting at a point 254 feet South of Southerly curb line of Bloomfield Avenue and running 18 feet South therefrom (6)

32 Watsessing Avenue, East curb, starting at a point 218 feet North of the Northerly curb line of Westinghouse Plaza and running 20 feet North therefrom. Placard #P1212156

214 Ampere Parkway, East curb, starting at a point 200 feet North of the Northerly curb line of Abington Avenue and running 20 feet North therefrom. Placard #p2234118 (2<sup>nd</sup> Flr)


**Section 2.** All ordinances inconsistent herewith are hereby repealed.


