AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:


- (712) 24 Chapel Street, North curb, starting at a point 144 feet East of the Easterly curb line of Broughton Avenue running 20 feet East therefrom. Placard # 2663319 (Apt. 2)
- (713) 14 Evelyn Place, West curb, starting at a point 200 feet North of the Northerly curb line of James Street running 20 feet North therefrom. Placard # P2436874
- (714) 183 Davey Street, East curb, starting at a point 270 feet South of the Southerly curb line of Donald Street and running 20 feet South therefrom. Placard # P2690969 (Apt. D)
- (715) 108 North 15th Street, East curb, starting at a point 71 feet South of the Southerly curb line of First Avenue and running 20 feet South therefrom. Placard # P2444071 (Apt. 1L)
- (716) 112 North 17th, First Avenue, South curb, starting at a point 62 feet East of the Easterly curb line of North 17th Street and running 20 feet East therefrom. Placard # P2637787 (Apt. 1)

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.




