**2023 RESOLUTION - AWARD OF A PROFESSIONAL SERVICE CONTRACT  
STORMWATER MODELING & RECOMMENDATIONS - REMINGTON & VERNICK**

**WHEREAS**, the Township of Bloomfield has a need to acquire professional services for stormwater modeling & recommendations for improvements to the Township’s storm sewer system; and

**WHEREAS**, the Township desires to make this appointment using one of our previously approved consultants for General Engineering Services; and

**WHEREAS**, the Township Engineer has determined that the value of these services may exceed \$17,500.00; and

**WHEREAS**, Remington & Vernick Engineers, Inc., 2059 Springdale Road Cherry Hill, NJ 08003 (hereinafter the “professional”) has previously performed mapping of he Township’s stormwater system and is uniquely suited to performing this service; and

**WHEREAS**, the professional will provide these services at a cost not to exceed 113,000.00; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of these services in Capital account no C-04-55-223-502.

**NOW, THEREFORE, BE RESOLVED** that the Mayor and Council of the Township of Bloomfield authorizes the award of a professional service contract to Remington & Vernick Engineers, Inc., 2059 Springdale Road, Cherry Hill, NJ 08003 in an amount not to exceed 113,000.00 for the above referenced project.
