**2023 RESOLUTION - CONTRACT AMENDMENT - PRINTING SERVICES FOR THE BLOOMFIELD WATER DEPARTMENT - CONTRACT NO. 23-00117**

**WHEREAS**, The Township of Bloomfield is in need of professional services related to printing and distribution of the Bloomfield Water Department Consumer Confidence Report and various public notices; and

**WHEREAS**, the Township made this appointment under the provisions of N.J.S.A. 19:44A-20.5, as a non-fair and open contract; and

**WHEREAS**, the cost of this work may exceed \$17,500.00; and

**WHEREAS**, Cara Graphics, Inc., (the "professional") 311 Route 46 West, Fairfield, NJ, has completed and submitted the attached Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous year and that the contract will prohibit Cara Graphics, Inc. from making any reportable contributions through the duration of this contract; and

**WHEREAS**, during the course of this work, additional services were required to fulfill various public notice requirements as required by the N.J. Department Of Environmental Protection (NJDEP); and

**WHEREAS**, printing and distribution of these public notices is mandatory under the NJDEP and EPA Federal Safe Drinking Water Regulations; and

**WHEREAS**, the additional cost for these printing and mailing services was in the amount of \$8,696.55; and

**WHEREAS**, it is the recommendation of the Township Engineer that this amendment to contract 23-00117 be approved; and

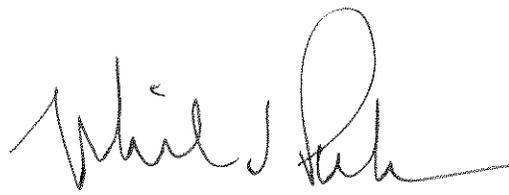
**WHEREAS**, the Director of Finance has indicated that funding is available in Township Account Number 3-05-55-502-023.

**NOW THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield hereby authorize the Township Engineer to amend Contract 23-00117 for an increase the contract amount by \$8,696.55.

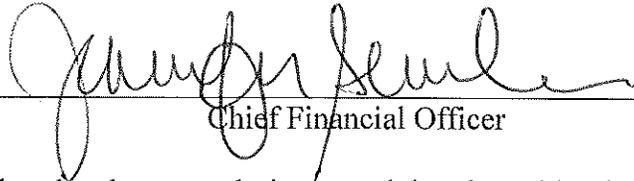

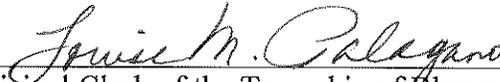

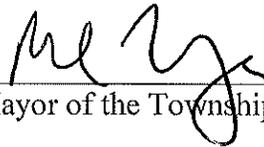
