**2023 RESOLUTION CHAPTER 159**

**RESOLUTION REQUESTING APPROVAL OF ITEMS OF REVENUE AND  
APPROPRIATION NJS 40A:4:87**

**BUDGET CHAPTER 159/15**

**WHEREAS**, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

**WHEREAS**, said Director may also approve the insertion of any items of appropriation for equal amount; and

**WHEREAS**, after the 2023 budget was adopted, the Township of Bloomfield became informed of the availability of revenue in the amount of \$32,400.00 from the Safe and Secure Communities Grant for the period of time from January 1, 2023 through December 31, 2023.

**NOW, THEREFORE, BE IT RESOLVED**, the Township of Bloomfield hereby requests the Director of the Division of Local Government Services approve the insertion of an item of revenue in the amount of \$32,400.00 for the Safe and Secure Communities Grant (Current Fund Revenue Account #3-01-08-390-000); and



**BE IT FURTHER RESOLVED**, that this resolution be filed with the Director of the Division of Local Government Services, Department of Community Affairs.






