2023 ORDINANCE AGREEMENTS

AN ORDINANCE TO REPEAL CHAPTER 315, LAND DEVELOPMENT AND ZONING, SECTION 315-37(D)(3), "CERTAIN PERMITTED AND PROHIBITED USES." WITHIN THE CODE OF THE TOWNSHIP OF BLOOMFIELD

WHEREAS, Section 315-37 (D)(3) within the Code of the Township of Bloomfield specifically prohibits the following uses within the Township: "Tattoo parlors and establishments of any nature whatsoever which utilize needles for the purpose of making indelible markings upon the body by the insertion of pigment under the skin or by production of scars"; and

WHEREAS, Chapter 514 of the Code of the Township of Bloomfield sets forth the requirements for conducting any business where tattooing is performed within the Township, including the specific licensure, medical certification and certificate of sanitation required to operate a tattooing shop. Now, therefore

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield that Chapter 315, Land Development and Zoning, Section 315-37, entitled "Certain permitted and prohibited uses", subsection (D)(3), within the Code of the Township of Bloomfield, Essex County, New Jersey is hereby repealed, thus permitting tattoo shops and establishments subject to compliance with all other existing local and state laws and ordinances.

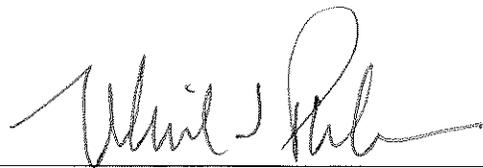
Section 1. All ordinances inconsistent herewith are hereby repealed.
