**2023 RESOLUTION - AWARD OF CONTRACT - 2023 NJDOT LOCAL TRANSPORTATION PROJECTS FUND (LTPF-202-00024) - ROADWAY RECONSTRUCTION - CONTRACT A**

**WHEREAS**, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on November 1, 2023 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the 2023 NJDOT Local Transportation Projects Fund (LTPF-202-00024); and

**WHEREAS**, a total of ten (10) bids were received and were referred to the Township Engineer for review; and


**WHEREAS**, after review of the bids it was determined that the lowest responsible bidder was by KM Construction Corp., 14 Cordier Street, Irvington, NJ 07111 in the amount of \$1,155,815.50; and

**WHEREAS**, the Director of Finance has indicated that funding is available within Capital Account No. C-04-55-232-905 which is fully reimbursable through the 2023 NJDOT Local Transportation Projects Fund Grant (LTPF-202-00024).

**NOW THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above improvements with KM Construction Corp., 14 Cordier Street, Irvington, NJ 07111 in the amount of \$1,155,815.50.
