RESOLUTION: AMENDING CONTRACT TO W.E. TIMMERMAN CO. INC. FOR REPAIRS MADE TO LARGE TRUCKS WITHIN THE TOWNSHIP OF BLOOMFIELD FLEET LIST

WHEREAS, the Township of Bloomfield needs the services of W.E. Timmerman Co. Inc. to make repairs to the larger fleet vehicles; and

WHEREAS, on September 18, 2023 the Mayor and Council approved resolution # R23-396 to W.E. Timmerman Co. Inc. provide services at a cost not to exceed \$55,000; and

WHEREAS, the Director of the Department of Public Works recommends amending the contract cost with W.E. Timmerman Co. Inc. for this service

WHEREAS, the Director of Finance has indicated that funding is available for this amendment.

NOW, THEREFORE BE IT RESOLVED, the Mayor and & Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby amends this contract for repairs to the larger fleet vehicles by adding \$80,000 for larger feet vehicles with the Township of Bloomfield with W.E. Timmerman Co. Inc., for a total amount not to exceed \$135,000; and




