2023 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS (removal)

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4, "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the deletion of the following:

36 Edison Street, West curb, starting at a point 114 feet South of the Southerly curb line of Alva Street and running 20 feet North therefrom. Placard #P1796186

210 Franklin Street, South curb, starting at a point 138 feet East of the Easterly curb line of Berkeley Place and running 20 feet East therefrom. Placard #P2531417

66 Linden Avenue, South curb, starting at a point 57 feet East of the Easterly curb line of Clinton Street and running 20 feet East therefrom. Placard #P2649248

253 Ampere Parkway, West curb, starting at a point 106 feet North of the Northerly curb line of Beardsley Avenue and running 20 feet North therefrom. Placard # P2649248

100 North 15th Street, East curb, starting at a point 153 feet South of the Southerly curb line of First Avenue and running 20 feet South therefrom.

103 North 15th Street, West curb, starting at a point 148 feet South of the Southerly curb line of First Avenue and running 20 feet South therefrom. Placard #P1852476

36 Columbus Street, East curb, starting at a point 60 feet South of the Southerly curb line of Alva Street and running 20 feet South therefrom. Placard #P2335067 (1st Floor)


14 Walnut Street, West curb, starting at a point 680 feet South of the Southerly curb line of Montgomery Street and running 20 feet South therefrom. Placard #p2101929

Section 2. All ordinances inconsistent herewith are hereby repealed.


