**RESOLUTION DESIGNATING THE OFFICIAL NEWSPAPER FOR THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY, PURSUANT TO THE "OPEN PUBLIC MEETINGS LAW" P.L. 1975, CHAPTER 231**

**WHEREAS**, the "Open Public Meetings Law", P.L. 1975, Chapter 231, requires that notice be given to the public of the times, dates and places of all regular meetings and all conference meetings of the public bodies to which reference is made in said law; and

**WHEREAS**, the Mayor and Council adopted a Resolution on December 11, 2023 in which the meeting schedule for 2024, including the location and time of each meeting was provided to the public; and

**WHEREAS**, pursuant to the "Open Public Meetings Law" P.L. 1975, Chapter 231, the Mayor and Council must designate the official newspaper for the Township.

**NOW, THEREFORE, BE IT RESOLVED**, that the Municipal Clerk is authorized and directed to furnish certified copies of this resolution to The Independent Press, which is designated as the official newspaper for the Township of Bloomfield as it has the greatest likelihood of informing the public in the Township of Bloomfield; and

**BE IT FURTHER RESOLVED**, that the Township may also utilize WBMA-TV Channels 30/35; the Township's website, [www.bloomfieldtpnj.com](http://www.bloomfieldtpnj.com) the Bloomfield Life and The Star-Ledger in the event that publication deadlines cannot be met with The Independent Press if one of these other newspapers can publish a required legal notice in accordance with State statute, which would have the greatest likelihood of informing the public in the Township of Bloomfield; and

**BE IT FURTHER RESOLVED**, that the Municipal Clerk is hereby authorized and directed to post a certified copy of this resolution on the bulletin boards located on the first floor of the Municipal Building and the Municipal Clerk’s Bulletin Board on the second floor outside Room 214, 1 Municipal Plaza, Bloomfield, New Jersey.
