2023 RESOLUTION - AWARD OF A PROFESSIONAL SERVICE CONTRACT FOR CONSTRUCTION ADMINISTRATION AND INSPECTION SERVICES -2022 NJDOT LOCAL AID PROGRAM AND 2023 NJDOT LOCAL TRANSPORTATION PROJECTS FUND - JFK DRIVE NORTH & SOUTH, PHASES 1, 2A AND 3

WHEREAS, the Township of Bloomfield has a need to acquire professional services for Construction Administration and Inspection Services for the 2022 NJDOT Local Aid Program and 2023 NJDOT Local Transportation Projects Fund - JFK Drive North & South, Phases 1, 2A and 3; and

WHEREAS, the Township desires to make this appointment using one of our previously approved consultants for General Engineering Services; and

WHEREAS, the Township Engineer has determined that the value of these services may exceed \$17,500.00; and

WHEREAS, Bright View Engineering, 70 South Orange Avenue, Suite 109, Livingston, NJ (the Consultant) has provided proposals to perform these services in the total amount of \$142,000.00; and

WHEREAS, the Consultant is uniquely qualified to perform this work because they prepared the design and bid documents and are familiar with all aspects of the proposed work; and

WHEREAS, the Township Engineer recommends that these services be awarded to the Consultant in the amount of \$142,000.00; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of these services through Capital Roadway Account No. C-04-55-232-905.




