**2024 RESOLUTION CHANGE ORDERS**

**2024 RESOLUTION - PUBLIC WORKS GARAGE ROOF REPLACEMENT- CHANGE ORDER NO. 1 - FINAL**

**WHEREAS**, the Township of Bloomfield entered into a contract with Northeast Roof Maintenance, 649 Catherine Street, Perth Amboy, NJ 08861 in the lump sum amount of \$129,600 (hereinafter "the Contractor") for the above referenced contract; and

**WHEREAS**, during the course of the project, there were structural issues uncovered related to the interior support of the roof. To that end, the contractor was directed to provide additional work to bring the building into current building code requirements, including replacement of the roof columns; and

**WHEREAS**, Change Order No. 1 - Final represents an increase to the contract in the amount of \$5,971.00 for a revised contract amount of \$135,571.00 or an increase of 4.6 percent; and

**WHEREAS**, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the Change Order should be approved; and


**WHEREAS**, this Change Order was found to be beneficial and necessary; and

**WHEREAS**, the Chief Financial Officer certifies that funding is available within roadway capital accounts C-04-55-226-303.

**NOW THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.


