RESOLUTION: 2024 AWARD OF CONTRACT TO AXON ENTERPRISE, INC. / DBA EVIDENCE.COM- STATE CONTRACT# NEW JERSEY T0106/17-FLEET-00738 - FOR CONDUCTED ENERGY DEVICES (TASER) and EVIDENCE SHARING AND REDACTION ASSISTANT TOOL SERVICES.

WHEREAS, the Township of Bloomfield Police Department needs the ability to purchase support and services for our Conducted Energy Devices (Tasers) and evidence sharing service, which also includes redaction tools technology within the Police Department; and

WHEREAS, in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" the Township may, without advertising for bids, purchase any goods or services under a contract entered into on behalf of the state and through specified federal procurement programs, and

WHEREAS, AXON ENTERPRISE, INC. / DBA EVIDENCE.COM-, located at 17800 N 85th St. Scottsdale, Arizona 85255 was awarded STATE CONTRACT# New Jersey T0106/17-FLEET-00738, and

WHEREAS, AXON ENTERPRISE, INC. / DBA EVIDENCE.COM, will provide renewal services for Conducted Energy Devices (Tasers) and evidence sharing service, which also includes redaction tools technology, within the Police Department; and

WHEREAS, the Township IT Director has determined that the value of these services will exceed \$17,500; and

WHEREAS, the Director of Finance has indicated that funds are available to cover the cost of these services in account # 4-01-20-140-024.

WHEREAS, no minimum payment is implied or guaranteed, and

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby accepts the recommendation of the Township IT Director and authorizes the Police Chief or his designee to contract with AXON ENTERPRISE, INC. / DBA EVIDENCE.COM., for support services for Conducted Energy Devices (Tasers) and evidence sharing service, which also includes redaction tools technology not to exceed \$18669.00 as needed and as described herein.
