2024 RESOLUTION BUDGETS

**RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF BLOOMFIELD,
COUNTY OF ESSEX, NEW JERSEY, AMENDING THE 2024 TEMPORARY PARKING
UTILITY FUND APPROPRIATIONS, PURSUANT TO N.J.S.A 40A:4-20, PRIOR TO THE
ADOPTION OF THE 2024 MUNICIPAL BUDGET.**

WHEREAS, resolution R24-13 was adopted on January 8, 2024; and

WHEREAS, an emergent condition has arisen with respect to increase in temporary appropriations and no adequate provision has been made in the 2024 temporary appropriations for the aforesaid purpose; and

WHEREAS, N.J.S.40A: 4-20 provides for the creation of a temporary emergency appropriation for the purpose above mentioned; and

WHEREAS, the total emergency temporary resolutions adopted in the year 2024 pursuant to the provisions of Chapter 96, P.L. 1051 (N.J.S. 40A: 4-20) totaled \$762,703.00 for the Parking Utility Fund; and

WHEREAS, the total temporary appropriations adopted in the year 2024 including this resolution total \$762,703.00 for the Parking Utility Fund.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, County of Essex, New Jersey, (not less than two-thirds of all the members thereof affirmatively concurring) that in accordance with the provisions of N.J. S 40A: 4-20:

1. Resolution R24-13 is rescinded and replaced with this resolution
2. Emergency temporary appropriations be and the same are hereby made to the 2024 temporary budget per the attached list.
3. That said emergency temporary appropriation will be provided for in the 2024 Township Budget.
4. Adoption of this resolution will supersede the adoption of resolution R24-13 as amending temporary budget appropriations






