2024 RESOLUTION APPROVAL

2024 RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF BLOOMFIELD REFERRING TO THE TOWNSHIP PLANNING BOARD, PURSUANT TO N.J.S.A. 40:55D-26, A PROPOSED ORDINANCE TO REPEAL CHAPTER 315, LAND DEVELOPMENT AND ZONING, SECTION 315-37(D)(3), "CERTAIN PERMITTED AND PROHIBITED USES." WITHIN THE CODE OF THE TOWNSHIP OF BLOOMFIELD

WHEREAS, Section 315-37 (D)(3) within the Code of the Township of Bloomfield specifically prohibits the following uses within the Township: "Tattoo parlors and establishments of any nature whatsoever which utilize needles for the purpose of making indelible markings upon the body by the insertion of pigment under the skin or by production of scars"; and

WHEREAS, Chapter 514 of the Code of the Township of Bloomfield sets forth the requirements for conducting any business where tattooing is performed within the Township, including the specific licensure, medical certification and certificate of sanitation required to operate a tattooing shop; and

WHEREAS, the Mayor and Council wish to resolve that apparent inconsistency and to recognize tattoo parlors as legitimate business enterprises appropriate for operation in two commercial zones within the Township of Bloomfield, namely the CBD Central Business District and the B-2 Neighborhood Business District; and

WHEREAS, amendments to multiple provisions of Chapter 315 are necessary to effectuate changing tattoo parlors from a use prohibited throughout the Township to one permitted in two specific commercial zones; and

WHEREAS, the Municipal Land Use Law ("MLUL") requires in N.J.S.A. 40:55D-26 that all ordinances constituting a development regulation must be referred to the Planning Board

for review to determine whether there are any inconsistencies between the proposed ordinance

and the Township Master Plan and for any other recommendations the Planning Board may have

with respect to the proposed ordinance; and

WHEREAS, by this resolution, the Mayor and Council hereby refer to the Planning Board the aforementioned Ordinance for its review pursuant to N.J.S.A. 40:55D-26; and

WHEREAS, the Mayor and Council will take any Planning Board recommendations under review and make amendment to the aforementioned Ordinance as may be required.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, Essex County, New Jersey, as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The Mayor and Council of the Township of Bloomfield hereby direct the Township of Bloomfield Planning Board to review, pursuant to N.J.S.A. 40:55D-26, the proposed Ordinance repealing Chapter 315, Land Development and Zoning, Section 315-37, entitled "Certain permitted and prohibited uses", subsection (D)(3), which prohibits "Tattoo parlors and establishments of any nature whatsoever which utilize needles for the purpose of making indelible markings upon the body by the insertion of pigment under the skin or by production of scars."

Section 3. The Township Clerk is hereby directed to forward a copy of proposed the Ordinance to the Planning Board for its review.

Section 4. This Resolution shall take effect immediately.


