2024 RESOLUTION - AWARD OF CONTRACT FOR LION GATE PARK LANDSCAPE MAINTENANCE

WHEREAS, after the required legal advertising was published, sealed bids for the Lion Gate Park Landscape Maintenance Contract were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on March 7, 2024 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law"; and

WHEREAS, a total of four (4) bids were received and were referred to the Township Director of Recreation; and

WHEREAS, lowest responsible bid was submitted by Property Services Landscaping, 344 Broughton Ave., Bloomfield, NJ 07003 for a total price, including Alternate A- C of an amount of \$26,304.40; and

WHEREAS, the bids were reviewed by the Director of Recreation and found to be complete and responsive; and

WHEREAS, the Director of Recreation is recommending a contract be awarded for a twelve (12) month period with options for two (2) additional twelve month extensions agreeable to both the vendor and Township of Bloomfield; and

WHEREAS, the Director of Finance has indicated that funding is available in account #4-01-28-375-024.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Director of Recreation and he may enter into a contract for the Lion Gate

Park Landscape Maintenance with by Property Services Landscaping, 344 Broughton Ave., Bloomfield, NJ 07003 for a total price, including Alternate A- C, in an amount not to exceed \$26,304.40 for a twelve (12) month period with options for two (2) additional twelve month contract extensions.




