2024 RESOLUTION - AWARD OF A PROFESSIONAL SERVICE CONTRACT FOR DESIGN AND BID SERVICES FOR 2024 NJDOT LOCAL AID PROJECT - IMPROVEMENTS TO NEWARK AVENUE

WHEREAS, the Township of Bloomfield has a need to acquire professional services for Design and Bid Services for the 2024 NJDOT Local Aid Project - Newark Avenue Improvements; and

WHEREAS, the Township desires to make this appointment using one of our previously approved consultants for General Engineering Services; and

WHEREAS, the Township Engineer has determined that the value of these services may exceed \$17,500.00; and

WHEREAS, the Township Engineer solicited proposal from the various consultants providing General Engineering Services to the Township; and

WHEREAS, CME Associates, 3141 Bordentown Avenue, Parlin, NJ (hereinafter the "professional") were determined by the Township Engineer to be most qualified in experience and cost to provide these services; and

WHEREAS, the professional will provide these services at a cost not to exceed \$101,572.50; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of these services within the following Roadway Capital Accounts:

Account No.	C-04-55-232-905	\$ 1,149.07

NOW, THEREFORE, BE RESOLVED that the Mayor and Council of the Township of Bloomfield authorizes the award of a professional service contract to CME Associates, 3141 Bordentown Avenue, Parlin, NJ in an amount not to exceed \$101,572.50 for the above referenced project.


