**2024 RESOLUTION: AWARD OF CONTRACT FOR NEGLIA ENGINEERING FOR ENGINEERING CONSULTANT SERVICES FOR THE PITT/BALDWIN STREET PARKING LOT PROJECT**

**WHEREAS**, Neglia Engineering is an approved Engineering Consultant via Resolution R24-49 approved on 02/12/2024; and

**WHEREAS**, Neglia Engineering has provided a written proposal to provide Engineering Services for the Pitt/Baldwin Street Parking Lot Project in the amount not to exceed \$50,000.00; and

**WHEREAS**, this contract will take effect on January 1, 2024 and will end on December 31, 2024; and

**WHEREAS**, the Township Administrator has determined that these services are necessary and be awarded to Neglia Engineering; and

**WHEREAS**, the Director of Finance is certified that funds are available to cover the cost of these services in account U-08-55-226-501; and


